



A firm has closed down

A firm may close voluntarily, in which case it will make arrangements with its [clients](https://upgrade.sra.org.uk/consumers/using-solicitor/legal-jargon-explained#client) [\[https://upgrade.sra.org.uk/consumers/using-solicitor/legal-jargon-explained#client\]](https://upgrade.sra.org.uk/consumers/using-solicitor/legal-jargon-explained#client) to deal with any ongoing work, and to arrange for the return of clients' papers and money.

A firm may have been abandoned and closed suddenly. This could be due to the death or sudden illness (more often the case with sole practitioners than with firms). We may already have closed the firm. We do this if we consider it necessary to protect clients' [interests](https://upgrade.sra.org.uk/consumers/using-solicitor/legal-jargon-explained#interests) [\[https://upgrade.sra.org.uk/consumers/using-solicitor/legal-jargon-explained#interests\]](https://upgrade.sra.org.uk/consumers/using-solicitor/legal-jargon-explained#interests) and money, and for the protection of the wider public.

When a firm closes down, it will have consequences for
