However, there are still some areas of concern, so we have produced guidance alongside that review, along with general guidance on the supervision of staff – an issue touched on in the review – for all firms now that flexible working is so widespread. Our new guidance on the Government's financial sanctions regime should be a must-read for all of you, as is our warning notice on abusive litigation aimed at stifling proper scrutiny (Strategic Litigation against Public Participation - SLAPPs). There is also still time to have your say on how a scheme for negligence claims made more than six years after a firm closes might be run. ## **Guidance issued on abusive litigation**

With the issue of the misuse of abusive litigation aimed at silencing legitimate critics, known as strategic lawsuits against public participation (SLAPPs) continuing to be of concern we have issued guidance to help those potentially on the receiving end of such action. Alongside this we have issued a warning notice to law firms, making it clear that such behaviour is not acceptable, and advising you what to do if you feel other firms are engaging in such activity.

There is still time to have your say on our proposals for arrangements and rules for an indemnity scheme to provide future consumer protection for post six-year negligence. We would run the scheme, which would, come into effect from September 2023.
