We are consulting on the arrangements and rules for an indemnity scheme that we run. This would provide future consumer protection for post six-year negligence, which will come into effect from September 2023. Have your say on the proposals.

Following changes in laws regarding how personal data is used, we are reintroducing a requirement for those without practising certificates to tell us you wish to remain on the roll of solicitors. Ahead of this it is important that all solicitors without a practising certificate check that their contact details within mySRA are up to date.

We have already told you about the sanctions the government has put in place in response to Russia's ongoing military offensive in Ukraine. The government has said it will impose further restrictions on transactional legal services (not legal advice) for Russian clients. Implementation dates have yet to be announced.

The Association of British Investigators has drafted a code of conduct to make sure investigative and litigation support service providers comply with their data protection obligations. This still needs approval by the Information Commissioners Office. The legal profession is the largest source of commissions for ABI members, so you should become familiar with the code's contents.
